### **General Explanations**

In the Law No. 6698 on the Protection of Personal Data ("KVK Law"), personal data subjects (hereinafter referred to as the "Applicant"), who are defined as the data subject, are granted the right to make certain requests regarding the processing of personal data in Article 11 of the KVK Law.

Pursuant to the first paragraph of Article 13 of the KVK Law, the applications to be made to our Company, which is the data controller, regarding these rights must be submitted to us in writing by other methods determined by the Personal Data Protection Board ("Board").

In this context, applications to be made to our Company in "written" form may be submitted to us by printing out this form as follows:

- By personal application of the Applicant,
- Through a notary public,
- By signing with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 by the Applicant and sending it to the Company's registered e-mail address.

Our responses will be delivered to you in writing or electronically in accordance with Article 13 of the relevant KVK Law.
